Due to the state of the epidemic emergency in Poland and in the interest of your health safety, the formula of public consultations of the draft document of the LARAP has been changed. There will be no meeting open to all interested parties, however the consultations will be conducted in an electronic form using the available (secure) electronic communication channels.
